RESOLUTION: Commit to Supporting Registered Nurses and Advanced Practice

Registered Nurses in Increasing Awareness of Naloxone in the Reversal of Overdose from Opioids and the Availability of

Naloxone in Mississippi

WHEREAS, Naloxone is a life-saving medication that can reverse an overdose from opioids—including heroin, fentanyl, and prescription opioid medications—when given in time, and won't harm someone if they are overdosing on drugs other than opioids¹; and

WHEREAS, provisional data from the Centers for Disease Control and Prevention (CDC) National Center for Health Statistics show overdose deaths involving opioids, including fentanyl, increased from an estimated 70,029 in 2020 to 80,816 in 2021²; and

WHEREAS, Expanding the awareness and availability of naloxone is a key part of the public health response to the opioid epidemic³; and

WHEREAS, through a standing order issued by the Mississippi Department of Health, pharmacists are permitted to dispense by request the narcotic blocker naloxone without an individual prescription⁴: and

WHEREAS, Registered Nurses and Advanced Practice Registered Nurses are committed to the promotion of health and safety issues for the public; and
